Steam Crane Appeal

Dear Swanage Railway Supporter,

Last year, the Swanage Railway was fortunate to acquire a Southern Railway steam crane. We now need your help to get it working again.



The crane, built in 1940 by Ransomes and Rapier for the Southern Railway, is generally in good condition as a significant amount of work was done prior to its arrival at Swanage, notably to the boiler and the lifting gear. However, there is still some work to be done including overhaul of the jib runner (the wagon beneath the jib), replacement of some steel platework, renewal of many of the cab and boiler fittings and, as you can see – some more paint. In relative terms compared to some of the projects that have been completed recently, the task is not huge, but nevertheless it all costs money. The estimate is £12,000 and with your help we can get it finished in time to help with the coming winter work programme.

So why do we need a 45 ton steam crane, when we have several other cranes which have served us well over the years? Put simply – size matters. Our two diesel electric cranes have a capacity of around 20 tons which makes them ideal for most of our permanent way and infrastructure needs. However, while 20 tons sounds a lot – and it is – if it is necessary to lift a loco, even just one end if it is a Bulleid, then 20 tons is not enough. Also, the 20 ton capacity drops rapidly to the extent that the lift is to the side and with reach from the line on which the crane is standing. Thus many smaller awkward lifts are beyond the capacity of the cranes we

have. To accomplish these lifts today we often have to hire a road crane which aside from the expense (around £1000 per day) is hardly convenient given the limited road access to most parts of the railway.

So this crane ticks the 'need' box in that when it is working it has the potential to save us money. Does it tick other boxes? Yes it does! Being a genuine 'Southern Railway' crane, it falls precisely within our charitable heritage remit to preserve and restore such things. And finally, a big crane is a fascinating thing to see in action and as such is an attraction in its own right which should bring more visitors to our railway.

If these are not reason enough to support this appeal, let me close with some more history. The crane was one of six ordered in April 1939 by the Government as part of Air Raid Precautions planning. Two went to the SR and four to the GWR. Ours, number 1561S, was based at Guildford to be close to London. After the war it served at Ashford, Brighton and Stewarts Lane and had the honour of being the last steam crane – and the last standard gauge steam powered vehicle - in service with British Railways when retired in April 1988.

I hope you can help us bring this useful crane back to life.
